Progress Report

Since September, the Modest Means Committee has: 1) filmed a one hour on-demand CLE on ethics required for attorneys who would like to join the directory and 2) finalized the language on the Modest Means Online Legal Directory.

The One-Hour Modest Means CLE

In order to join the directory, attorneys are required to view a one-hour CLE that includes an overview of the Modest Means Online Legal Directory ("Directory") and discusses ethical obligations to consider when representing clients with limited means. During the first portion of the CLE, LSBA President-Elect Barry Grodsky provides an overview of the online directory, the attorneys' responsibilities as an LSBA member listed on the Directory, and eligibility requirements of a prospective user to view the directory. The second portion of the CLE is presented by Loyola New Orleans College of Law Professor Dane Ciolino, who presents ethical considerations when representing someone with limited means including engagement and non-engagement agreements, fee arrangements, communication, and competency. The one-hour CLE is available on the Online CLE section of the LSBA website. There is a \$40 fee to complete the CLE, which covers the cost of hosting it on-demand on the web. However, the Committee has decided to waive the cost for the first 50 attorneys who join the directory. Additionally, attorneys in the LSBA's LIFT program will be able to watch the CLE and join the Directory at no cost.

The Modest Means Website

During its last meeting, the Committee reviewed and finalized the verbiage appearing on the various pages of the Directory (available at: www.lsba.org/ATJCommission/ModestMeans.aspx). In order to test the functionality and usability of the website, the members would like prospective users eligible to view the Directory and attorneys who might agree to join to review and provide feedback before going live. To this end, the Committee will work with legal aid and pro bono organizations to get feedback from potential users. Additionally, staff has requested feedback from attorneys in LSBA's LIFT Incubator Program, who have practices dedicated to serving modest means clients.

Next Steps

Over the next few months, the Committee will work to invite attorneys, namely solo and small firm practitioners, to complete the CLE and join the directory. Once the directory has over 50 attorneys listed representing more than 10 parishes, notice will be sent to our ATJ partners to share the directory with those who do not qualify for free legal services, but fall below the 400% federal poverty guidelines. As requested, the Committee will provide a report to the LSBA Board of Governors on the progress of the Directory.

ATJ Commission Modest Means Committee 2017-2018 Action Plan

Modest Means Committee Mission: The Louisiana Access to Justice Commission Modest Means Committee was established to brainstorm and develop ways to address the legal needs of modest means clients – clients who do not qualify for free legal services from non-profit civil legal service programs, but are unable to afford the average market rate for legal representation.

Strategic Priority #1: Develop an online legal directory that will match modest means clients with attorneys offering reduced fee legal representation and services.
