SPEAKER BIOS

Michael S. Walsh, Of Counsel, Taylor Porter, Brooks & Phillips L.L.P., Baton Rouge

Michael Walsh has over 30 years of experience representing individual and corporate clients in complex criminal and civil litigation and enforcement cases throughout the country. Mr. Walsh has built a practice that includes a variety of grand jury and trial matters. His practice involves public corruption, antitrust, healthcare, False Claims Act, Lacey Act, and environmental matters. Mr. Walsh currently chairs the Louisiana State Bar Association's Criminal Law Section. Mr. Walsh has served as president of the Baton Rouge Bar Association and the Louisiana Association of Criminal Defense Lawyers, and he has served as chairman of the Louisiana Attorney Disciplinary Board. Mr. Walsh is an adjunct professor of law at LSU's law school, where he teaches a course on Professional Responsibility and Ethics, and he is a frequent lecturer on ethics, professionalism, and litigation skills. Mr. Walsh graduated from Louisiana State University, Paul M. Hebert Law Center in 1983. He earned a Bachelor of Science degree from LSU in 1979.

Emily K. Greenfield, Assistant U.S. Attorney, Eastern District of Louisiana

Emily Greenfield graduated cum laude from Tulane Law School in 2003 and received a certificate in Environmental Law. She has been a federal prosecutor in the Eastern District of Louisiana for 9 years. The last 4 years she has prosecuted environmental crimes and sits on the United States Department of Justice's Environmental Crimes Policy Committee. Michael Daniels, Criminal Enforcement Counsel, Louisiana Department of Environmental Quality, Baton Rouge

Mike Daniels has 23 years' experience as a criminal prosecutor including stints at the New Orleans District Attorney's Office, Louisiana Attorney General's Office and Louisiana State Police. Mike joined LDEQ in 2009 as its criminal enforcement counsel. He has been appointed as a special prosecutor in Jefferson Davis, Ascension, St. James, Evangeline, Sabine, and Orleans parishes. Mike has made numerous presentations to civic, legal and governmental organizations on environmental crimes, including Keep Louisiana Beautiful's National Conference in 2013. He has also been an attorney advisor at the Federal Law Enforcement Training Center's Advanced Environmental Crimes Training Program.

J. Michael Bowman, Baldwin, Haspel, Burke & Mayer, LLC, New Orleans

Mike Bowman joined Baldwin Haspel Burke & Mayer in 2012, moving from Indiana where he practiced environmental law and complex litigation. Mike received a B.A. in mathematics from the University of Chicago in 1985, a M.S. in environmental engineering from Purdue in 1990 and a J.D., magna cum laude, from Indiana University – Robert H. Donald W. Washington – Jones Walker LLP, Lafayette

Donald W. Washington, a partner in Jones Walker, has a practice that includes complex civil and criminal litigation and the representation of corporations and individuals in internal and government investigations. Mr. Washington served as United States Attorney for the Western District of Louisiana from 2001 to early 2010. Mr. Washington has more than 20 years of experience as a trial attorney, litigator and counselor. Anne Rolfes, Founding Director of the Louisiana Bucket Brigade, began her career in Nigeria, collaborating with local communities to address oil industry impacts in the Niger Delta. She returned to Louisiana in 2000 and founded the Louisiana Bucket Brigade. The organization has created cutting edge tools, including the iWitness Pollution Map, and the Refinery Accident Database. Anne was born and raised in Lafayette, Louisiana. She has a Masters in International Development from Tulane. Ms. Rolfes has twice testified before Congress. Her work has been recognized by local and national awards, including the Jane Bagley Lehman Award for Public Advocacy and the Robert Wood Johnson Community Health Leader Award.
