## Keynote Speaker Tanner D. Magee Louisiana State Representative, District 53 Houma

Tanner D. Magee is a lawyer and a Republican member of the Louisiana House of Representatives. He was first elected to the District 53 seat (Terrebonne and Lafourche parishes) in 2015. As a freshmen legislator, he was appointed by the Speaker of the House to the Coastal Protection and Restoration Authority and by the Republication delegation to the Policy Committee. A Houma native, he received his JD degree from Louisiana State University Paul M. Hebert Law Center, where he was named to the Chancellor's List and served on the Moot Court Board. He began his legal career in New Orleans with the insurance defense firm of Taylor, Wellons, Politz & Duhe, A.P.L.C. He later moved back to Houma and developed his reputation as the top felony criminal defense attorney in Terrebonne Parish. He worked for the public defender's office for a year and worked as a contract lawyer for Samanie and Stipelcovich, A.P.L.C. Magee is president-elect of the Terrebonne Bar Association. In 2015, he was recognized by the National Trial Lawyers Association as one of the "Top 40 Under 40" and by the Terrebonne Chamber of Commerce as a Young Achiever. In 2017, he was recognized as a *Louisiana Super Lawyers* Rising Star. In his community, he is an alumnus of Leadership Terrebonne and is involved with Le Petit Theatre.
