After reminding Board members that this was a special meeting to provide information on the lawyer advertising review process, Mr. Dwyer introduced Rules of Professional Conduct Committee Chair Richard C. Stanley and turned the meeting over to him.

Mr. Stanley gave an overview of the evaluation process, noting that the Committee voted in September to revise its internal operating procedures to provide for an appeal process when members disagreed with the informal opinion. He noted that there initially was a review process but that it had been inadvertently omitted when the procedures were revised several years ago. Mr. Stanley then opened the meeting for questions and comments from Board members. Mr. Elliott, Mr. Sternberg, Mr. David, Mr. Johnson, Mr. Centola and Ms. Smith shared their experiences with the process, with all of them expressing some dissatisfaction.

After some discussion, the consensus was that staff and leadership would look into the following issues and report back to the Board at its November meeting:

- Status of implementation of appeal process;
- Status of updating Handbook on Lawyer Advertising and Solicitation to reflect January 1, 2022 changes;
- Policy regarding submission of non-substantive changes to previously approved ads and payment for same;
- Origin of \$175 filing fee;
- Consideration of filing fee reduction for new lawyers; and
- Demographics of those submitting filings.

Mr. Dwyer advised that he would work with staff on these issues and thanked Board members for their participation and input.

Adjourn

There being no further business, the meeting was adjourned at 4:40 p.m.
