- I. **Welcome and Introductions** Judge Lisa Woodruff-White welcomed the group and asked everyone to introduce themselves.
- II. **Consent Calendar** A motion to accept the Consent Calendar was made by Tina Suggs, seconded by Professor Luz Molina and adopted by voice vote.

III. Review of 2023 Committee Conversations and Activities

- **a. Heir Property** –Adrienne Wheeler reported that funding has been made available to continue work with heir property legal clinics. Louisiana Appleseed plans to create a will generator for legal aid attorneys. Appleseed will also work on the passage of the Uniform Partition of Heirs Property Act in 2024.
- **b. Disaster Pro Bono Cases** –Work continues on the expansion of an "expert panel" particularly for emergency case where public interest attorneys may need consultations in areas of the law with which they are less familiar. (e.g., construction law)
- **c. Data Collection** –Judge Lisa Woodruff White reported that the data collected by the NCSC for the American Judges Association showed that a personal touch service such as non-lawyer legal navigators works well. Law students and social workers are a great resource for legal navigators. d. Educational Issues

- i. Interdiction/Supported Decision Making Jane Thomas reported that the Governor's office is installing 6 half-hour videos on becoming a Family Curator. After viewing the videos, participants may be eligible for "family curator" status.
- **ii.** Educating Domestic Violence Organizations Stephanie Beaugh and Rachael Mills met with DART to share our resources for Domestic Violence. DART used these resources as a starting point to develop a web page for DV adjacent legal issues. With funding provided by LBF, DV organizations are adding attorneys to their offices and SLLS will provide training for these domestic violence attorneys.

IV. ATJ Commission Committee and Initiatives

- **a. ATJ Conclave** –Amy Ducan and Monte **Mollere** discussed the results of the conclave which recognized the need for continued education for lawyers and the public. The United Way 211 data has been very useful in identifying the need for legal help to be incorporated in a holistic approach to care for the underserved community. Collaboration among the organizations and marketing ideas need to be explored.
- **b.** Accessibility Committee –Luz Molina and Stephanie Beaugh announced the Language Access Committee's focus is being broadened to include accessibility issues and being renamed the Accessibility Committee. The committee seeks additional members.

V. ATJ Committee Subcommittee and Initiatives

- **a.** Lawyers in Libraries Stephanie Beaugh reminded the committee that Lawyers in Libraries will take place Oct. 23-27 with volunteers meeting library patrons in-person in libraries and telephonically. Hourlong presentations are planned by Zoom each day on legal topics of interest to the public.
- **b. Disaster Law Summit** –Acadiana Legal Service Corp. and Southeast Louisiana Legal Services are hosting the 2nd Annual Disaster Law Summit on June 20th and 21st, 2024 at the Doubletree Hotel in Lafayette, Louisiana. ATJ Staff is coordinating this event.

a. Amy Duncan introduced new LIFT Fellow, Kelly Stephens to the committee.
