# 2. COVID-19 Updates

- During the last meeting, various COVID-19-related resources were shared. SLLS continues to post COVID-related resources on their web page under "Blog", which can be accessed <a href="here">here</a>.
- Disability Rights Louisiana also has a <u>COVID-19 Resource page</u> with helpful links to information and resources related to the pandemic and not just legal resources.

## 3. Disability Law CLE 2020

 Given COVID-19 and social distancing requirements, the committee supports moving the CLE to an online platform as long as it can be accessible to the disability community. Read more about how to make virtual meetings and events accessible <a href="here">here</a>.

- Note that the Supreme Court waived online CLE restrictions through the end of the year. The committee could host a series of CLEs between November and December. There has been some pushback from local bars regarding free CLEs, so staff will need to check with CLE department to see if we can offer it for free.
- Programming Last year's topics included: Clients & Capacity;
  Attorney Obligations & the ADA; and Public Benefits. What topics would this committee like to focus on this year? Derek Warden has offered to present on the history of the disability rights movement.
- 4. Justice Index 2020 The LSBA is helping to answer a survey for National Center for Access to Justice's Justice Index 2020. It includes questions related to 4 areas of information in Louisiana Courts: Attorney Access, Language Access, Self Help, and Disability Access. The Disability Access survey includes 29 questions regarding service delivery, court services, etc. We're hoping members of this committee could help us answer the Disability Access survey by the end of June. Some of these issues may be good projects for this committee to work on in the future.
- 5. Bar Journal The committee discussed interest in submitting an article for the Bar Journal. Derek Warden offered to work on an article regarding the ADA.
- 6. Policy/Legislative Updates
  - Margot Hammond is tracking legislation and will later provide a memo with updates.
  - During the last meeting, this committee discussed the proposed bills allowing for notarial acts by electronic means in light of the particular needs of persons with disabilities. Thanks to this committee, the LSBA's Board of Governors determined it will support position for HB 274 on two conditions: (1) they add an LSBA member to the stakeholder committee, and (2) they try to make the process simpler for attorneys.
