
## Nominating Committee to meet Aug. 28 to nominate president-elect, secretary

The Nominating Committee of the Louisiana State Bar Association (LSBA) will meet on Friday, Aug. 28, in New Orleans to nominate a president-elect for the 2021-22 term and a secretary for the 2021-23 term. The president-elect will automatically assume the presidency in 2022-23.

According to the president-elect rotation, the nominee must have his/her preferred mailing address in Nominating Committee District 2 (parishes of Ascension, Assumption, East Baton Rouge, East Feliciana, Iberville, Jefferson, Lafourche, Livingston, Pointe Coupee, St. Charles, St. Helena, St. James, St. John the Baptist, Tangipahoa, Terrebonne, Washington, West Baton Rouge and West Feliciana).

According to the secretary rotation, the nominee must have his/her preferred mailing address in Nominating Committee

### Election Schedule

For the 2020-21 election cycle, balloting will be conducted electronically only, as approved by the LSBA Board of Governors. No paper ballots will be provided.

The Nominating Committee report will be submitted to the Board of Governors on Saturday, Aug. 29.

On Monday, Sept. 21, notice of the action of the Nominating Committee and self-qualification forms for positions on the Board of Governors, LSBA House of Delegates, Nominating Committee, Young Lawyers Division and American Bar Association House of Delegates will be provided to the membership.

Deadline for return of nominations by petition and qualification forms is

Monday, Oct. 19. First election ballots will be available to members on Monday, Nov. 16. Deadline for electronically casting votes is Monday, Dec. 14.

### Other Positions Open

Other positions to be filled in the 2020-21 elections are:

**Board of Governors** (three-year terms beginning at the adjournment of the 2021 LSBA Annual Meeting and ending at the adjournment of the 2024 LSBA Annual Meeting) — one member each from the Sixth, Seventh and Eighth Board Districts.

**LSBA House of Delegates** (two-year terms beginning at the commencement of the 2021 LSBA Annual Meeting and ending at the commencement of the 2023 LSBA Annual Meeting) — one delegate from each of the Twentieth through Forty-Second Judicial Districts, plus one additional delegate for every additional district judge in each district.

**Nominating Committee** (15 members, one-year terms beginning at the adjournment of the 2021 LSBA Annual Meeting and ending at the adjournment of the 2022 LSBA Annual Meeting) — District 1A, Orleans Parish, four members; District 1B, parishes of Plaquemines, St. Bernard and St. Tammany, one member; District 2A, East Baton Rouge Parish, two members; District 2B, Jefferson Parish, two members; District 2C, parishes of Ascension, Assumption, East Feliciana, Iberville, Lafourche, Livingston, Pointe Coupee, St. Charles, St. Helena, St. James, St. John the Baptist, Tangipahoa, Terrebonne, Washington, West Baton

Rouge and West Feliciana, one member; District 3A, Lafayette Parish, one member; District 3B, parishes of Acadia, Beauregard, Calcasieu, Cameron, Iberia, Jefferson Davis, St. Martin, St. Mary and Vermilion, one member; District 3C, parishes of Allen, Avoyelles, Evangeline, Grant, LaSalle, Natchitoches, Rapides, Sabine, St. Landry and Vernon, one member; District 3D, parishes of Bossier and Caddo, one member; and District 3E, parishes of Bienville, Caldwell, Catahoula, Claiborne, Concordia, DeSoto, East Carroll, Franklin, Jackson, Lincoln, Madison, Morehouse, Ouachita, Red River, Richland, Tensas, Union, Webster, West Carroll and Winn, one member.

**Young Lawyers Division. Secretary** (2021-22 term), nominee shall not be a resident of or actively practicing law in the parishes of Orleans, Jefferson, St. Bernard or Plaquemines, based on preferred mailing address. Petitions for nomination must be signed by 15 members of the Young Lawyers Division. Also to be elected, one representative each from the First, Second, Fourth, Fifth, Sixth and Eighth districts (two-year terms).

**American Bar Association House of Delegates** (*must be members of the American Bar Association*) — one delegate from the membership at large. The delegate will serve a two-year term, beginning with the adjournment of the 2021 ABA Annual Meeting and expiring at the adjournment of the 2023 ABA Annual Meeting, as provided in Paragraph 6.4(e) of the ABA Constitution.

The Louisiana Supreme Court on April 28 issued an order lifting the cap on self-study mandatory continuing legal education credits for calendar year 2020. The “self-study” credits were increased to 12.5 hours annually (for 2020). Carryover hours for 2021, however, are still limited to in-person CLE attendance. ## LBF awards \$35,000 in 2020-21 Kids' Chance Scholarships

The Louisiana Bar Foundation's (LBF) Kids' Chance Scholarship program awarded \$35,000 in scholarships to seven students. Scholarships are awarded to dependent children of Louisiana workers killed or permanently and totally disabled in an accident compensable under a state or federal Workers' Compensation Act or law.

The LBF Kids' Chance Program was started in 2004 and is administered by the LBF and governed by a committee representing a cross-section of the state's legal and workers' compensation communities. Since 2004, the LBF has awarded 313 scholarships totaling \$754,000.



# Supreme Court amends Rule XVIII to create emeritus status, effective FY 2020/2021

The Louisiana Supreme Court on April 9 issued an order amending Rule XVIII to allow for emeritus status for lawyers meeting the following criteria — an active member of the Louisiana State Bar Association in good standing; 50 years of age or older; and actively practiced law in Louisiana for a minimum of 10 years.

Lawyers electing emeritus status shall pay 50 percent of the annual bar dues and disciplinary fee for lawyers practicing three years or more. A lawyer electing emeritus status will restrict his/her activities to the following:

- ▶ engage in pro bono practice of law through a program established, sponsored

or recognized by the LSBA's Access to Justice Program, [www.lsba.org/ATJ](http://www.lsba.org/ATJ);

- ▶ participate in any mentoring program established by the LSBA, [www.lsba.org/mentoring](http://www.lsba.org/mentoring);

- ▶ engage in the uncompensated representation of immediate family members, as defined in La. R.S. 42:1102;

- ▶ serve on LSBA committees, [www.lsba.org/BarGovernance/Committees.aspx](http://www.lsba.org/BarGovernance/Committees.aspx); and

- ▶ serve on receivership team panels, [www.lsba.org/Transitioning](http://www.lsba.org/Transitioning).

The Louisiana State Bar Association's (LSBA) House of Delegates approved a resolution in January 2020 to amend the LSBA's Bylaws to create emeritus status

and to recommend to the membership that it approve corresponding amendments to the Association's Articles of Incorporation. The members approved the Articles amendments in February.

Attorneys will be able to elect emeritus status and pay the reduced fees beginning with Fiscal Year 2020/2021.

# Deadline extended to Aug. 1 for payment of 2020-21 LSBA dues and LADB assessment, filing statements

**D**ue to the COVID-19 pandemic and its impact, the Louisiana Supreme Court and the Louisiana State Bar Association (LSBA) have extended the deadline for payment of the 2020-21 LSBA dues and the Louisiana Attorney Disciplinary Board (LADB) assessment and filing of the Attorney Registration Statement and the Louisiana Supreme Court Trust Account Disclosure and Overdraft Notification Authorization Form. The new deadline is Aug. 1, 2020. Postcards were mailed to all Louisiana lawyers in May and reflect the due date of Aug. 1 rather than the usual July 1.

New for this year's dues cycle is the category of Emeritus Status for lawyers who only handle pro bono work or uncompensated work for family members (both subject to certain guidelines and restrictions) and who meet age and practice criteria. Prior to making the dues and assessment payments, lawyers should review the Emeritus Status guidelines and restrictions for possible election. Review the "Emeritus Status Guidelines and Restrictions and Notice of Application" online at: [www.lsba.org/Members/EmeritusStatus.aspx](http://www.lsba.org/Members/EmeritusStatus.aspx).

LSBA members have the option to pay their LSBA dues and LADB assessment by ACH electronic check, credit card, or download and mail their Attorney Registration Statement and checks for the payment of fees. Members are encouraged to pay and file electronically, as this access will be available 24/7, including times when the Bar Center is closed or if mail service is disrupted due to inclement weather. Further, electronic payment gives members more control over their information in the database and allows for more timely updates to their member records. To complete and file Attorney Registration Statements and pay annual dues and the assessment online, go to: [www.lsba.org/goto/MemberDues](http://www.lsba.org/goto/MemberDues).

Filing electronically can be a quick and simple process, utilizing the online

member accounts that participants have relied on for years to register for CLE seminars and to access Fastcase. If an attorney has not yet set up a member account, one can easily be created at: [www.lsba.org/Members/memberacct.aspx](http://www.lsba.org/Members/memberacct.aspx). This webpage also allows members to edit their existing accounts and reset a lost or forgotten account password.

After member data is confirmed but before the payment/filing process begins, members will be advised that they also need to go to [www.LADB.org](http://www.LADB.org) to complete the Louisiana Supreme Court Trust Account Disclosure and Overdraft Notification Authorization Form and will be asked to confirm that they understand this requirement.

The collection schedule will be the same as in prior years. In lieu of mailing a statement to each member, in May, the LSBA mailed to each member a postcard, which provides instructions to go online to [www.LSBA.org](http://www.LSBA.org) to complete the registration process, and to go online to [www.LADB.org](http://www.LADB.org) to complete the Trust Account Form. ***This is the only mailing members will receive prior to the Aug. 1, 2020, extended due date; attorney registration statements will NOT be mailed.***

With the email address, [compliance@lsbamembership.com](mailto:compliance@lsbamembership.com), the LSBA will email reminders throughout the dues collection period. Members are encouraged to add this email address to their contact list to avoid missing important communications. Members should not reply to this email address, but rather direct questions to [processing@lsba.org](mailto:processing@lsba.org).

Once members have electronically filed their Attorney Registration Statements (including any necessary changes and/or updates) and made the required payments, they will receive email confirmations. The filing and payment deadline has been extended to Aug. 1. The LSBA will continue to mail delinquency and ineligibility notices to

those who fail to meet the deadlines.

Members who elect to pay by electronic check will continue to pay the following fees:

- ▶ LSBA dues (practicing more than three years): \$200;
- ▶ LSBA dues (Emeritus Status): \$100; and
- ▶ LSBA dues (practicing three years or less): \$80;
- ▶ LADB assessment (practicing more than three years): \$235;
- ▶ LADB assessment (Emeritus Status): \$117.50; and
- ▶ LADB assessment (practicing three years or less): \$170.

***Those who are planning to pay by electronic check should contact their financial institutions to confirm that their accounts allow payment by this method. If your account is Positive Pay Protected, update the Company ID 1016207445.***

As was the case last year, processing fees of 3%, plus a .20 transaction fee, will be passed along to those choosing to pay by credit card. Total amounts, including credit card processing fees, are as follows:

- ▶ LSBA dues (practicing more than three years): \$206.20;
- ▶ LSBA dues (Emeritus Status): \$103.20; and
- ▶ LSBA dues (practicing three years or less): \$82.60;
- ▶ LADB assessment (practicing more than three years): \$242.25;
- ▶ LADB assessment (Emeritus Status): \$121.23; and
- ▶ LADB assessment (practicing three years or less): \$175.30.

# La. Board of Legal Specialization accepting requests for applications

The Louisiana Board of Legal Specialization (LBLS) is accepting applications for business bankruptcy law and consumer bankruptcy law certification from now through Sept. 30, 2020.

The LBLS will be accepting applications for certification in five additional areas — appellate practice, estate planning and administration, family law, health law and tax law — from Nov. 1, 2020, through March 1, 2021.

In accordance with the Plan of Legal Specialization, a Louisiana State Bar Association member in good standing who has been engaged in the practice of law on a full-time basis for a minimum of five years may apply for certification. Further requirements are that each year a minimum

percentage of the attorney's practice must be devoted to the area of certification sought, passing a written examination to demonstrate sufficient knowledge, skills and proficiency in the area for which certification is sought and five favorable references. Peer review shall be used to determine that an applicant has achieved recognition as having a level of competence indicating proficient performance handling the usual matters in the specialty field. Refer to the LBLS standards for the applicable specialty for a detailed description of the requirements for application: [www.lsba.org/documents/Specialization/LSBAPlanofLegalspecialization2017.pdf](http://www.lsba.org/documents/Specialization/LSBAPlanofLegalspecialization2017.pdf).

In addition to the above, applicants must meet a minimum CLE requirement for the year in which application is made and the

examination is administered:

- ▶ Appellate Practice — 15 hours of appellate practice law.
- ▶ Estate Planning and Administration — 18 hours of estate planning law.
- ▶ Family Law — 15 hours of family law.
- ▶ Health Law — 15 hours of health law.
- ▶ Tax Law — 18 hours of tax law.
- ▶ Bankruptcy Law — CLE is regulated by the American Board of Certification, the testing agency.

With regard to applications for business bankruptcy law and consumer bankruptcy law certification, although the written test(s) is administered by the American Board of Certification, attorneys should apply for approval of the Louisiana Board of Legal Specialization simultaneously with the testing agency in order to avoid delay of board certification by the LBLS. Information concerning the American Board of Certification will be provided with the application form(s).



## Four new solos join LIFT and deliver 300 pro bono hours in first 6 months

**F**our new solo practitioners joined the Louisiana State Bar Association's legal incubator program, Legal Innovators for Tomorrow (LIFT), at the beginning of 2020. While the year has presented many unforeseen challenges in the midst of COVID-19, the attorneys continue to pursue and develop their solo practices to ensure access to legal representation in areas where the demand for legal services has risen — estate planning, successions and family law.

Since January, the attorneys listed below have provided more than 300 pro bono hours combined and are using hands-on experience to develop their practice skills and increase access to legal representation.

LIFT operates under two projects — the Flood Proof Project and the Domestic Violence Project.

The **LIFT Flood Proof Project** helps people affected by the 2016 flood in Baton Rouge settle property disputes, gain clear title and handle matters involving succession law. The attorneys in the program provide these services at no cost and receive a stipend through a grant from the Louisiana Bar Foundation. Additionally, the attorneys receive mentorship, case management software, legal research tools and training during the 18-month program from the partners — Southeast Louisiana Legal Services (SLLS), Southern University Law Center, American Bar Association Center for Innovation, Louisiana State University Paul M. Hebert Law Center and the LIFT program. The program welcomed its second class of participants, Shawn B. (Pepper) Roussel and LaKendra D. Sampson, in 2020.

► **Shawn B. (Pepper) Roussel** is a graduate of Loyola University College of Law, an environmentalist, an ecoculinarian and a solo practitioner at Green Pepper Legal, which offers food and farm, business

transactions, land use, estate planning and successions services as well as assisting with bankruptcy cases in the U.S. District Court, Eastern District of Louisiana.

► **LaKendra D. Sampson**, with LaKendra D. Sampson, L.L.C., is a graduate of Southern University Law Center. Upon passing the bar exam, she immediately opened her law firm. She understands the impact that the lack of clear title can have on a family and seeks to help people with homes passed down through generations obtain clear title and keep inherited property family-owned for future generations.

The **Domestic Violence Project**, operated in partnership with the New Orleans Family Justice Center, Southeast Louisiana Legal Services (SLLS) and the LIFT program, was launched in 2015 to ensure domestic violence survivors have access to legal representation for legal matters that can go unaddressed due to gaps in available services. A. Camille Patti and Christine D. Thomas make up the fourth class of attorneys in this project.

► Attorney **A. Camille Patti** graduated *magna cum laude*, with a certification in civil law, from Tulane University Law School. She has been dedicated to social justice and increasing access to affordable legal services early in her career. At the New Orleans Family Justice Center in New Orleans, she offers family law-related legal services with a focus on survivors of domestic violence.

► Attorney **Christine D. Thomas** is a graduate of Loyola University College of Law. She has more than 20 years' professional experience in civil and criminal law and compliance. In 2019, she opened her own solo law firm focused on serving domestic violence survivors and providing passionate, affordable legal services to meet the needs of the community in family law, wills and successions.

Patti is already seeing the impact of her work in a short time during an emergency custody hearing: "We did the hearing via Zoom and were able to successfully reunite child and client. The client, who has limited English proficiency, had not been able to afford an attorney, which I believe directly impacted the previous custody proceedings while the courts were closed due to COVID-19."

Elena M. Perez, who manages SLLS's pro bono program and works closely with the attorneys in LIFT, said, "As a former solo practitioner, I know the exceptional effect hands-on legal experience has on an attorney developing a solo practice. And from a community perspective, the pro bono work the attorneys in LIFT are doing to meet the legal needs are already having a critical impact for people who are not able to obtain legal help elsewhere."
