# Elections: What members need to know about online voting

To make the online voting procedure as smooth as possible, here's what members need to know.

Members received an email with their Eballot on Monday, Nov. 13. The sender address was "LSBA Election Admin" and the Subject Line referenced "Vote now in the LSBA 2017-2018 Election."

The email includes a link to the voting website. On the voting website, members must type in their 5-digit member ID number and birth date to access the ballot. Ballots will only include races for which the member may cast a vote.

Members who do not have an email address, or members preferring to vote from the LSBA website, may log-in from the LSBA website to a special page and will be asked to enter the same credentials (5-digit member ID and birth date). The "Vote Now" icon will be active from Nov. 13 through the end of the voting period on Dec. 11.



The MCLE Committee is seeking comments on a proposal regarding a new CLE requirement aimed at improving legal writing.

The new CLE requirement would require attorneys who have been admitted to the practice of law in Louisiana for at least three (3), but not more than five (5) years, to obtain six (6) hours of CLE credits concerning legal writing. The proposal is aimed at improving the legal writing skills of attorneys who are still early in their careers, but who have gained a few years of experience in legal writing. Before further consideration of the proposal, the MCLE Committee is interested in hearing comments from members of the Bar and the public.





# LBLS sets dates for certification applications

The Louisiana Board of Legal Specialization (LBLS) is accepting requests for applications for certification in six areas.

The application period for appellate practice, estate planning and administration, family law and tax law certification will continue through Feb. 28, 2018.

Applications for business bankruptcy law and consumer bankruptcy law certification will be accepted from Jan. 1, 2018, through Sept. 30, 2018.

In accordance with the Plan of Legal Specialization, a Louisiana State Bar Association (LSBA) member in good standing who has been engaged in the practice of law on a fulltime basis for a minimum of five years may apply for certification. Further requirements are that each year a minimum percentage of the attorney's practice must be devoted to the area of certification sought, passing a written examination to demonstrate sufficient knowledge, skills and proficiency in the area for which certification is sought, and five favorable references. Peer review will be used to determine that an applicant has achieved recognition as having a level of competence indicating proficient performance handling the usual matters in the specialty field. LSBA members should refer to the LBLS standards for the applicable specialty for a more detailed description of the requirements for application.

In addition to the above, applicants must meet a minimum CLE requirement for the year in which application is made and the examination is administered:

► Appellate Practice — 18 hours of appellate law.

► Estate Planning and Administration — 18 hours of estate planning law.

► Family Law — 18 hours of family law.

► Tax Law — 18 hours of tax law.

▶ Bankruptcy Law — CLE is regulated by the American Board of Certification, the testing agency.

With regard to applications for business bankruptcy law and consumer bankruptcy law certification, although the written test(s) is administered by the American Board of Certification, attorneys should apply for approval of the LBLS simultaneously with the testing agency in order to avoid delay of board certification by the LBLS. Information concerning the American Board of Certification will be provided with the application form(s).

# Reminder: CLE compliance by Dec. 31 for board-certified specialists

In accordance with the requirements of the Louisiana Board of Legal Specialization (LBLS), as set forth in the individual Speciality Standards for each field of legal specialization, board-certified attorneys in a specific field of law must meet a minimum CLE requirement for the calendar year ending Dec. 31, 2017. The requirement for each area of specialty is:

► Appellate Practice — 18 hours of appellate practice law.

► Estate Planning and Administration Law — 18 hours of estate planning law.

► Family Law — 18 hours of family law.

► Tax Law — 18 hours of tax law

► Bankruptcy Law — CLE is regulated by the American Board of Certification.

CLE credits will be computed on a calendar year basis and all attendance information must be delivered to the Supreme Court Committee on Mandatory Continuing Legal Education (MCLE) no later than Jan. 31, 2018. Failure to earn and/or timely report specialization CLE hours will result in a penalty assessment.

Specialists who are not yet compliant in their specialization CLE hours for 2017 will be notified in November. Specialists should satify all specialization CLE requirements by Dec. 31, 2017

# 14th annual Louisiana Justice Community Conference focuses on "ATJ Heroes"

The two-day event offers time to focus on supporting access to justice through relevant poverty law training, networking and collaborations for public interest attorneys throughout the state.

This year's conference theme was "Access to Justice Heroes." The conference showcased those "heroes," often unrecognized, who work to change the lives of Louisiana's indigent population through their efforts of providing critical civil legal aid. Leading up to the conference, the LSBA ran a social media campaign to spotlight individ-

ual attorneys from civil legal aid providers who are dedicated and passionate about their work. Lewis M. Gladney, an attorney with Acadiana Legal Services Corp. and one of the heroes highlighted, has dedicated more than 35 years to a career in public interest.

LSBA President Dona Kay Renegar delivered a powerful keynote address to kick off the conference. As a former legal aid attorney, she spoke about her experience representing survivors of domestic violence in Acadiana Legal Service Corp.'s Alexandria office right after graduating law school. In her remarks, she recognized the vital role legal aid attorneys play in meeting the needs of residents and the ways in which the access to justice community are working to ensure stable funding for legal aid programs in Louisiana. She encouraged attendees to remain actively involved in the bar association activities to bring a voice to the voiceless.

The Justice Conference is also a time to highlight the exceptional work of individual attorneys and programs that have increased access to legal representation through excellent advocacy or innovative programming. To this end, two civil legal aid awards were presented.

The Legal Service Excellence in Advocacy Award was presented to Hannah D. Adams, staff attorney in the housing unit at Southeast Louisiana Legal Services, for her work preventing evictions, avoiding subsidy termination and representing low-

income and disabled clients, resulting in an economic impact of nearly \$1.3 million.

The Legal Service Innovation Award was presented to Sexual Trauma Awareness & Response (STAR) for its legal program. The program was established in 2015 to provide holistic and comprehensive legal services to sexual assault survivors, free of charge.

In addition to the regularly scheduled programming, the Child in Need of Care (CINC) Task Force, chaired by Danika A. Benjamin of Legal Aid of North Louisiana, hosted a six-hour pre-conference CLE program for CINC professionals.

The LSBA hosted a networking event that included door prizes and stand-up comedy performed by Southeast Louisiana Legal Services attorneys Amanda J. Golob and Hardell H. Ward.

The conference hosted participants from the state's legal service programs and nonprofit public interest firms, including the Advocacy Center, Greater New Orleans Fair Housing, Louisiana Civil Justice Center, Pro Bono Project, the Baton Rouge Bar Association, Crescent Care, Southwest Louisiana Law Center, Mental Health Advocacy Center and Project Save.

# LIFT welcomes two Shreveport attorneys in new collaborative program

The Louisiana State Bar Association's legal incubator program, Legal Innovators for Tomorrow (LIFT), welcomes Felicia M. Hamilton and Ebonee Rhodes Norris to the new program launched, in partnership with the Justice and Accountability Center (JAC), in Shreveport.

LIFT is designed to address the legal needs of underserved and underrepresented populations in Louisiana by supporting new attorneys in building viable and sustainable public interest solo practices. This project, in particular, focuses on reducing barriers for youth (ages 18-24) who are reintegrating to their communities after incarceration. Through their work, Hamilton and Norris will provide representation in expungements, public benefits and housing law that will ultimately reduce recidivism, promote public safety, and create positive results in communities.

While in LIFT, Hamilton and Norris will receive free tools, training, resources and a stipend to provide pro bono representation for those eligible. JAC leads this project under a program called Juvenile Re-Entry

Assistance Program (JRAP) and provides mentorship with substantive law training to the participating attorneys. Throughout the 15-month program, JAC and the new LIFT Fellows will host five legal clinics, in which individuals aged 24 and under who live or could live in public or Section 8 housing will have an opportunity for all expungement costs to be covered by a generous grant from the Department of Housing and Urban Development and the Housing Authority for the City of Shreveport.

# Online Modest Means Directory coming soon!

The Louisiana State Bar Association's (LSBA) Access to Justice Commission formed the Modest Means Committee in 2016 to examine ways in which the legal profession can meet the growing need for affordable legal services for those falling into the "justice gap" — *i.e.*, ineligible for free legal services but below 400 percent of the federal poverty guidelines.

After researching national and local modest means programs and surveying Louisiana lawyers to determine the availability of affordable legal services, the committee proposed an Online Modest Means Directory to connect attorneys offering discounted legal services with people who need them. This directory will provide a listing of attorneys who offer affordable legal services — in the form of sliding scale, reduced hourly, flat fees or other alterative fee arrangements — by parish and practice area on a page on the LSBA's website.

Attorneys who wish to be listed on the website will be required to complete a one-hour, on-demand CLE through the LSBA's online CLE programming and agree to the terms and conditions listed.

The public interested in accessing the list also must agree to certain terms and conditions and must verify that household income falls below 400 percent of the federal poverty guidelines.


