Fastcase contract renewed; free apps available for iPhone, iPad, iPod

The Louisiana State Bar Association (LSBA) renewed its contract with Fastcase in June to provide nationwide legal research as a free service to every LSBA member in good standing. In June 2005, the LSBA became the first state bar association in the nation to sign up for Fastcase, but, for many lawyers, the launch of that member benefit was lost in the aftermath of Hurricanes Katrina and Rita later that summer. With the recent contract renewal, the LSBA is now "relaunching" this benefit.

Fastcase is a fully nationwide system. Logging onto Fastcase, LSBA members have instant access to case law from all states, including Louisiana, at least back to 1950 (some states as far back as the 1700s). Fastcase also provides federal case law from the U.S. Supreme Court from 1 U.S. 1 (1754),

Musser currently represents the First District on the LSBA's Board of Governors. He is owner of the Law Office of John H. Musser IV in New Orleans, is of counsel to the Law Office of Leon A. Aucoin and Toledano and Herrin, and is a mediator with ADR inc.

Leefe currently represents the Second District on the LSBA's Board of Governors. He is a partner in the Metairie firm of Leefe Gibbs Sullivan Dupre & Aldous.

Centola, currently serving as YLS secretary, is an associate in the New Orleans firm of Martzell & Bickford.

Simar, currently serving as Third District representative on the YLS Council, is a 16th Judicial District Family Court hearing officer in St. Martinville.

The Nominating Committee also accepted the nomination of Monica Hof Wallace as the 2011-13 Loyola University College of Law's representative on the LSBA Board of Governors, as well as accepted the names to be submitted for the Board representatives from Southern University Law Center and the Louisiana State Law Institute.

On Sept. 27, all LSBA members will receive notice by mail of these nominations as well as self-qualification forms for these and several other LSBA leadership positions, including seats on the Board of Governors, House of Delegates, Nominating Committee, Young Lawyers Section and the American Bar Association's House of Delegates.

According to the president-elect rotation, the candidate must come from Nominating Committee District 1 (parishes of Orleans, Plaquemines, St. Bernard and St. Tammany).

According to the secretary rotation, the candidate must come from Nominating Committee District 2 (parishes of Ascension, Assumption, East Baton Rouge, East Feliciana, Iberville, Jefferson, Lafourche,

Livingston, Pointe Coupee, St. Charles, St. Helena, St. James, St. John the Baptist, Tangipahoa, Terrebonne, Washington, West Baton Rouge and West Feliciana).

Deadline for return of nominations by petition and qualification forms is Monday, Oct. 25. First election ballots will be available to members on Nov. 14. Deadline for electronically casting votes or for a U.S. postmark on mailed ballots is Monday, Dec. 13. Mailed ballots with a U.S. postmark of Dec. 13 or earlier must be received by Dec. 16 in order to be counted.

Other positions open for the 2010-11 elections are:

Board of Governors (three-year terms beginning at the adjournment of the 2011 LSBA Annual Meeting and ending at the adjournment of the 2014 LSBA Annual Meeting): one member each from the First, Second and Third Board districts.

Nominating Committee (15 members, one-year terms beginning at the adjournment of the 2011 LSBA Annual Meeting and ending at the adjournment of the 2012 LSBA Annual Meeting): District 1A, Orleans Parish, four members; District 1B, parishes of Plaquemines, St. Bernard and St. Tammany, one member; District 2A, East Baton Rouge Parish, two members; District 2B, Jefferson Parish, two members; District 2C, parishes of Ascension, Assumption, East Feliciana, Iberville, Lafourche, Livingston, Pointe Coupee, St. Charles, St. Helena, St. James, St. John the Baptist, Tangipahoa, Terrebonne, Washington, West Baton Rouge and West Feliciana, one member; District 3A, Lafayette Parish, one member; District 3B, parishes of Acadia, Beauregard, Calcasieu, Cameron, Iberia, Jefferson Davis, St.

Martin, St. Mary and Vermilion, one member; District 3C, parishes of Allen, Avoyelles, Evangeline, Grant, LaSalle, Natchitoches, Rapides, Sabine, St. Landry and Vernon, one member; District 3D, parishes of Bossier and Caddo, one member; and District 3E, parishes of Bienville, Caldwell, Catahoula, Claiborne, Concordia, DeSoto, East Carroll, Franklin, Jackson, Lincoln, Madison, Morehouse, Ouachita, Red River, Richland, Tensas, Union, Webster, West Carroll and Winn, one member.

LSBA House of Delegates (two-year terms beginning at the commencement of the 2011 LSBA Annual Meeting and ending at the commencement of the 2013 LSBA Annual Meeting): one delegate from each of the 20th through 42nd Judicial Districts, plus one additional delegate for every additional district judge in each district.

Young Lawyers Section: Chair-elect (2011-12 term), nominee shall be a resident of or actively practicing law in the parishes of Orleans, Jefferson, St. Bernard or Plaquemines, based on preferred mailing address. Secretary (2011-12 term), nominee shall not be a resident of or actively practicing law in the parishes of Orleans, Jefferson, St. Bernard or Plaquemines, based on preferred mailing address. Petitions for nomination must be signed by 15 members of the Young Lawyers Section. Also to be elected, one representative each from the First, Second, Fourth, Fifth, Sixth and Eighth districts (two-year terms).

ABA House of Delegates (must be a member of the American Bar Association): one delegate from the membership at large. The delegate will serve a term of two years, beginning with the adjournment of the 2011 ABA Annual Meeting and expiring at the adjournment of the 2013 ABA Annual Meeting.

Board of Governors discusses pro bono, pro se, other issues at meeting

The Louisiana State Bar Association's (LSBA) Board of Governors took action on several issues during its Aug. 28 meeting in New Orleans, including issues dealing with pro bono service, a pro se pilot project and the Louisiana Civil Justice Center.

The Board took the following action:

- ► Approved the Draft Model Firm Pro Bono Policy;
- ▶ Approved a Pro Se Pilot Project to develop, with the Louisiana Civil Justice Center, a court-based, self-help center for a three-month period to assist and survey pro se litigants within Orleans Parish Civil District Court:
- ► Approved a proposal to change the name of the Right to Counsel Committee to the "Criminal Justice Committee;"
- ▶ Approved a proposal to move forward with the 2011 Criminal Justice Summit (the first event was held in spring 2010);
- ▶ Approved the marketing proposal and fee schedule for the 2011 Annual Meeting, which will be held from Tuesday, June 28, through Thursday, June 30, at the Wynn Las Vegas;
- ► Approved recommending to the Louisiana Supreme Court the appointment of

James G. Dalfares, Monique B. Clement and Chauntis T. Jenkins to the Louisiana Board of Legal Specialization;

- ► Approved the slate of nominees for the Louisiana Civil Justice Center Board of Trustees:
- ► Approved a Data Security Policy for the Louisiana State Bar Association; and
- ► Approved signing the auditor engagement letter for the audit to be performed for FY 2009/2010.

In addition to reports from the officers, the Board also heard reports on and/or discussed:

- ► Results from the Aug. 27 Nominating Committee meeting (see related article on page 1);
- ► The Legislation Committee and its work during the 2010 Regular Session, as well as the plans for the upcoming year;
- ▶ Plans to update the Association's strategic plan since the action items from the 2008 plan have all been achieved: and
- ▶ Projects and programs of the Diversity Committee.

The next Board of Governors meeting is scheduled for Saturday, Oct. 30, in Baton Rouge.

all circuit courts from 1 F.2d 1 (1924), all district courts from 1 F.Supp. 1 (1914), and all bankruptcy courts from 1 B.R. 1 (1979). The cases show digest pagination for correct citation. New opinions are posted within 24 to 48 hours of issuance.

Additionally, Fastcase offers all state and federal statutes, administrative regulations and court rules. All state constitutions can be researched as well.

LSBA members are also able to access without fee several new á la carte resources, such as Louisiana legal forms, a nationwide newspaper search, a unified PACER search system, a people-finder application, and business intelligence tools.

Fastcase is a major benefit of membership to the LSBA. Included in the regular cost of Bar dues, members get complete access to Fastcase, which normally costs \$995 per user per year. The benefit is gaining traction, too. Today, 18 state bar associations (and several major international law firms with thousands of lawyers) subscribe to Fastcase for their members — more than 400,000 users strong and growing all the time.

To log in to Fastcase, go to the LSBA website's home page at www.lsba.org, and either click on the "Fastcase" logo on the right or on the word "Fastcase" on the left. Members' usernames and passwords remain the same as their current login for other LSBA website features. Members who may have forgotten their usernames and/or passwords can get reminders with a link on the login screen.

Fastcase supports terms and connectors (or "Boolean") searching, natural language searching, and searching by citation. Searches use the same syntax as most commercial legal research, so users of other



legal research services will find the system familiar. In addition, there are video tutorials, user guides and training materials available on the site — offering a good introduction to Fastcase and a good brush-up course on legal research. Find them at www.fastcase.com/support.

Fastcase is designed specifically to be a smarter approach to finding the law, not just a more affordable one. One example of this smarter approach is that search results come back "best case first," just like searching on the web. Instead of a one-size-fits-all approach, users can re-sort search results a dozen different ways, customizing the list to fit the precise research task. Fastcase displays

information about the cases in the results list, including the citation and either the most relevant paragraph or the first paragraph of the case.

A new, interesting feature unique to Fastcase is its Interactive Timeline which creates visual maps of results, so users can see all of the search results at a glance, how they fall over time, and which are most relevant, most cited and most recent.

Additionally, Fastcase offers Foresite which augments search results with other relevant cases, which cite to cases in search results but which do not contain all of the search terms. It is especially useful when attempting to trace the origins of a particular legal precept.

Unlike most other web-based utilities, Fastcase offers dual-column printing of cases, in Microsoft Word, PDF or WordPerfectcompatible Rich Text Format.

On the run or in court, and need a case cite or statute quickly? Fastcase has an app for that. Download and use the free Fastcase app for iPhones, iPads and iPods to get material instantly. Users can access anything in the Fastcase database with the app.

Legal specialization available in bankruptcy law

The Louisiana Board of Legal Specialization (LBLS) is accepting applications for 2011 certification in business bankruptcy law and consumer bankruptcy law through September 2010.

In accordance with the Plan of Legal Specialization, any Louisiana State Bar Association member who has been engaged in the practice of law on a full-time basis for a minimum of five years may apply for certification. The five-year practice requirement must be met for the

period ending Dec. 31, 2010. A further requirement is that each year a minimum of 35 percent of the attorney's practice must be devoted to the area of certification sought. For bankruptcy law, the CLE is regulated by the American Board of Certification, the testing agency.

Regarding applications for business bankruptcy law and consumer bankruptcy law certification, although the written test(s) is administered by the American Board of Certification, attorneys should apply for approval of the LBLS simultaneously with the testing agency in order to avoid delay of board certification by the LBLS. Information concerning the American Board of Certification will be provided with the application form(s).

Educational courtroom at Lake Charles-Boston Academy complete

The Louisiana Bar Foundation (LBF) formed a partnership with Lake Charles-Boston Academy of Learning (LCB Academy) and built a fully functioning courtroom on its Lake Charles campus. The courtroom is fitted with judge, jury and advocate seating and serves as the setting for mock trial competitions, speaker functions and future court proceedings.

A ribbon-cutting ceremony was conducted on Sept. 9.

The LBF's Southwest Community Partnership Panel (CPP) designated \$15,000 to pay for the construction of the courtroom. The LBF has nine regional CPPs that work outside of the LBF's regular grant process to identify new areas of need for LBF funding, foster collaboration, respond to arising community needs, and encourage local involvement in the designation of LBF grant funds.

The LCB Academy is designated as a Law Signature School by the Louisiana Center for Law and Civic Education. Law Signature Schools have a core, law-related education curriculum available to high school students. This designation allowed the LBF to fund the building of the courtroom.

Established in July 2007, the LCB Academy was designed to create a center for extension learning services that expands and enhances the educational, artistic and career preparation of students throughout the Calcasieu school system. The law-related education curriculum will be available to the 11 schools in the Calcasieu school system, as well as to schools in Jeff Davis, Allen, Beauregard and Cameron parishes.

58th annual Red Mass, LSBA Memorial Exercises set for Oct. 4 in New Orleans

The 58th annual Red Mass, sponsored by the St. Thomas More Catholic Lawyers Association and the Catholic Bishops of Louisiana, will begin at 9:30 a.m. Monday, Oct. 4, at St. Louis Cathedral in New Orleans. 



Inclusiveness 101

Ithough the legal profession has worked very hard in recent years to open its long closed doors to diverse populations, the profession's limited focus on diversity without consideration of inclusion has changed the open doors into revolving doors. Many of our workplaces invest in the recruiting and hiring of diverse populations only to see increasing attrition rates within these groups. We need to do more than open the doors to diverse populations; we need to open the doors and ensure that the workplaces are actually welcoming of the different backgrounds and perspectives.

Diversity vs. inclusiveness: What's the difference? Many people use the terms "diversity" and "inclusiveness" interchangeably but they have very different meanings. **Diversity** describes "compositional diversity" — the extent to which a legal organization has people from diverse backgrounds and communities working as attorneys and staff. Primary dimensions of diversity include race, ethnicity, gender, age, religion, disability, sexual orientation and gender expression. Secondary dimensions of diversity can include lifestyle, communication style, personality type, learning style, economic status, geographic origin, education status, generation, avocation, work experience, world travel experience, political views, philosophical views, parental status, appearance, veteran status and nationality.

Inclusive organizations not only have a diverse composition, but are also learning-centered organizations that value the perspectives and contributions of all people, and strive to incorporate the needs and viewpoints of diverse communities into all aspects of the organization. Inclusive organizations are, by definition, diverse at all levels. **Inclusion** is the active, intentional and ongoing engagement with diversity in the organization.

Diversity is about your workforce; inclusiveness is about your workplace. Diversity is about recruiting; inclusiveness is about retention. The legal profession will continue its "revolving door" syndrome, with extremely high attrition rates for diverse attorneys, until it embraces both diversity and inclusiveness.
