# LSBA, ABA/YLD offering free legal assistance to Hurricane Isaac survivors; attorney volunteers needed to assist efforts

Survivors of Hurricane Isaac needing legal advice are taking advantage of free legal counseling via a toll-free hotline (1-800-310-7029), part of the overall disaster response and relief plan activated by the Louisiana State Bar Association (LSBA), in collaboration with the American Bar Association Young Lawyers Division (ABA/YLD), the Louisiana Civil Justice Center (LCJC) and the Federal Emergency Management Agency (FEMA).

Attorney volunteers are still being sought to provide brief legal advice and counseling to individuals impacted by the hurricane, either at local Disaster Recovery Centers (DRCs) or in conjunction with the disaster telephone hotline. Volunteers also are sought to handle cases with their local pro bono programs. To volunteer your legal services, contact Cristin Fitzgerald at cfitz@fitzbrownlaw.com or (504)564-7677, or contact your local pro bono program.

At the request of Louisiana Gov. Bobby Jindal, President Obama signed the major disaster declaration authorizing the release of federal disaster funds and resources for the survivors of the storm in 16 parishes: Ascension, Assumption, Jefferson, Lafourche, Livingston, Orleans, Plaquemines, St. Bernard, St. Charles, St. Helena, St. James, St. John the Baptist, St. Tammany, Tangipahoa, Terrebonne and Washington.

Through the call center and staff provided by LCJC, as well as volunteer efforts coordinated by the LSBA and the ABA/YLD, working with FEMA, legal information/advice is being provided to low-income storm survivors who have been financially impacted by the storm.

LCJC operates the hotline from 10 a.m. to 5 p.m. Mondays through Thursdays, and returns voicemail messages on Fridays from 10 a.m. to 3 p.m. Staff will provide resources and assist callers with legal issues, including FEMA disaster assistance, insurance claims, landlord-tenant issues, home-repair contracts, consumerprotection matters. Legal assistance for Spanish-speaking callers can be arranged via a callback appointment.

Callers are being made aware that there are some limitations on disaster legal services. For example, assistance is not available for cases that will produce a fee (*i.e.*, those cases where attorneys are paid part of the settlement by the court). Such cases are referred to a local lawyer referral service. Hotline staff helps determine

# Supreme Court launches 24-hour e-filing system

The Louisiana Supreme Court has launched a 24-hour electronic filing (e-filing) system. The voluntary system allows lawyers to file documents online, after first completing a 30-minute online training session and obtaining a password. The system was activated on Aug. 1.

The e-filing system will be implemented in several phases with an aim toward improving and enhancing the system over time.

Chief Justice Catherine D. (Kitty) Kimball commended Justice Marcus R. Clark for shepherding this project to allow attorneys statewide to do business with the Supreme Court online. She also acknowledged the Clerk of Court staff, the Information Technology staff and all of the attorneys who participated in focus group testing of the system.

A 30-minute online training session is provided on the Louisiana Supreme Court's website, www.lasc.org, and completion is required to access e-filing. After training is completed, a password is provided and documents can be filed online as they would be filed conventionally, except that required copies of the e-filed documents will be made by the Clerk of Court's Office rather than by the attorneys themselves. At this time, e-filing is limited to attorneys in good standing with the Louisiana Supreme Court. Technical assistance will be provided by the Clerk of Court's Office during regular business hours.

"Our e-filing system allows for 24hour access and is designed to work with various levels of technical expertise and equipment. All attorneys throughout the state will now have the opportunity for quick and easy access to the Court around the clock," Justice Clark said.

To cover the costs of implementing the e-filing system and preparing the number of copies required by court rule, there is a \$100 fee for e-filing writ applications and a \$50 fee for e-filing other court documents such as oppositions, replies and amicus curiae briefs. These e-filing costs are in addition to the regular filing fees. The court will continue to accept filings by hand or mail delivery in accordance with existing court rules.

# Two-day CLE to address legal ethics training for criminal law practitioners

Stakeholders in Louisiana's criminal justice system — working as the "Criminal Attorney Accountability Working Group" — have created an intensive, two-day legal ethics CLE program to be offered jointly to prosecutors and defense attorneys.

The first training session, supported by a grant from Baptist Community Ministries, is Oct. 12-13 at Tulane Law School, 6329 Freret St., New Orleans, for up to 200 participants. Organizers have applied for 12.25 ethics and professionalism CLE credits.

Participants should register online by Oct. 7 at *http://tiny.cc/criminalethicstraining*. The \$100 registration fee will be refunded in its entirety upon proof of full attendance. Because the program involves an extended hypothetical case, participants must be present for the entire training; no partial CLE credit will be given and the registration fee will only be refunded to those who attend the entire program. Questions may be emailed to criminalethicstraining@hotmail.com.

The Working Group's CLE program is modeled on the National Institute for Trial Advocacy's hypothetical-based trainings, specifically addressing legal ethics issues in criminal practice. The centerpiece of the training will be a hypothetical homicide case — modeled on an actual case from New Orleans — complete with mock police reports, memoranda, statements and videotaped interviews with witnesses. The participants will be split into groups of 10, with each group playing the defense or the prosecution over the two days.

The hypothetical case touches on a variety of ethics issues faced by criminal practitioners, including disclosure

obligations, charging decisions, working with law enforcement, witness safety, incentivized witnesses, lying witnesses, the duty to investigate, conflicts of interest (for defenders *and* prosecutors), and what to do when there are no resources for the defense that is ethically required.

Interspersed with sessions on the hypothetical case will be panels and presentations by leaders in Louisiana's criminal justice system, as well as those who have been personally impacted by a wrongful conviction resulting from attorney misconduct.

The Working Group was motivated to create this program by the lack of legal ethics training programs focused specifically on criminal law practitioners. Another motivation was the knowledge of how profoundly an unethical lawyer can impact the lives of others in the criminal system. "It's one thing for a lawyer to steal someone's money, but it's quite another for a lawyer's ethical violation to cause an innocent person to be convicted of a crime," said Working Group member Charles B. Plattsmier, chief disciplinary counsel for the Office of Disciplinary Counsel. "Not only does that ruin the life of the innocent defendant, but it utterly fails the victim and creates the opportunity for a guilty person to commit more crimes."

The Working Group includes lawyers from the prosecution side (Graymond F. Martin, first assistant district attorney, Orleans Parish; Stephen T. Wimberly, first assistant district attorney, Jefferson Parish; Tracey N. Knight, assistant U.S. attorney, New Orleans), the defense side (Jean M. Faria, state public defender; Julie H. Kilborn, state deputy public defender; Frank X. Neuner, Jr., chair, Louisiana Public Defender Board; James E. Boren, defense attorney, Baton Rouge), the judiciary (Susanne J. Inman, deputy executive counsel, Louisiana Supreme Court; Calvin Johnson, former chief judge, Orleans Parish Criminal District Court; Hon. D. Milton Moore III, judge, Louisiana 2nd Circuit Court of Appeal; Hon. Fredericka H. Wicker, judge, Louisiana 5th Circuit Court of Appeal), from the legal ethics and professionalism world (Mark A. Cunningham, former treasurer, Louisiana State Bar Association; Charles B. Plattsmier, chief disciplinary counsel, Office of Disciplinary Counsel; Steven R. Scheckman, former special counsel, Louisiana Judiciary Commission; Michael S. Walsh, former chair, Louisiana Attorney Disciplinary Board), from academia (Andrea C. Armstrong, professor, Loyola University College of Law; Janet Hoeffel, professor, Tulane Law School; Pamela Metzger, professor, Tulane Law School; Imre Szalai, professor, Loyola College of Law), and from other perspectives in the criminal justice system (Luceia LeDoux, vice president, Public Safety and Government Oversight Grants, Baptist Community Ministries; Emily L. Maw, director, Innocence Project New Orleans; Paul A. Killebrew, staff attorney, Innocence Project New Orleans; Jon Wool, director, New Orleans Office, Vera Institute of Justice).

The Working Group plans to present this program at other locations in Louisiana in the future.

"Lawyer Depression is Contagious!" By Michael D. Yapko, Ph.D.

Can you catch a depressed mood the way you catch a cold? Not exactly . . . but similar. Can other people really be a source of the rising rate of depression in the United States? The scientific evidence suggests the answer is yes. Our social lives play a huge role in how we think and feel. After all, none of us are immune to the influence of others, for better or worse. How we react to others, and vice-versa, even has a measurable biological impact on our brain chemistry, as our newest brain research shows us. The evidence is rapidly mounting that depression is about much more than just an individual's "bad chemistry." Thinking of depression as a brain disease is proving to be too onedimensional a perspective.

For attorneys, appreciating the social connection to depression is vital if the person is to be viewed — and responded to — realistically. Why are attorneys depressed?
